Purpose

Gamma-ray energies will be measured with a High-Purity Germanium (HPGe) detector and research-grade electronics. The principles behind the response characteristics of the detector are explained. The high-resolution measurement results are contrasted with those obtainable from the NaI(TI) (sodium iodide) scintillation detector previously explored in Experiment 3.

Introduction

Most of the experiments in this series are written for use with lower-cost detectors and electronic modules. However, in this experiment, which illustrates the superior resolution capabilities of the high-performance HPGe detector systems, research-grade signal processing modules have been incorporated to fully utilize the detector's capabilities.

Many colleges, universities, and national research laboratories have Nuclear Spectroscopy Centers that employ high-resolution gamma-ray spectrometry to investigate decay schemes of radioisotopes. Given the plethora of isotopes, opportunities continue to arise in exploring the details of the decay schemes. Improved energy resolution allows additional lines to be found in spectra. Occasionally, a doublet is discovered, whereas earlier measurements with NaI(TI) detectors indicated only a single energy line.

High-Purity Germanium (HPGe) detectors are also extensively used to detect and monitor radioactivity in the environment, and to detect contraband radioisotopes and fissionable material. It is the excellent energy resolution of the HPGe detector that enables ultra-low detection limits in these applications.

High-Resolution Gamma-Ray Spectroscopy

Decay schemes for isotopes are included in refs. 10 and 12. More recent information on certain nuclei can be found in ORTEC's Nuclide Navigator Master Library software package (Model C53-B32). An up-to-date on-line resource for such information is sponsored by:

In Experiment 3, gamma-ray spectroscopy with NaI(TI) detectors was studied. The typical energy resolution that can be obtained with NaI(TI) is circa 7% for the 0.662 MeV ¹³⁷Cs gamma-ray line. For NaI(TI) detectors, the resolution is a strong function of energy. The resolution is primarily controlled by the statistical fluctuation of the number of photoelectrons produced at the photocathode surface in the photomultiplier tube. Table 7.1 illustrates some typical resolutions for a NaI(TI) detector as a function of the gamma-ray energy. Note that it is conventional to express the resolution in percent for NaI(TI) detectors.

% Resolution (FWHM) =
$$\frac{\delta E}{E}$$
 x 100% $\approx \frac{k \times 100\%}{\sqrt{E}}$ (1)

Where

E is the energy of the peak,

δE is the FWHM of the peak in energy units, and

k is a proportionality constant characteristic of the particular detector.




Fig. 7.1. A Portion of a [∞]Co Spectrum, Illustrating the Energy Resolutions and Peak-to-Compton Ratios for a Coaxial HPGe Detector Compared to a Nal(TI) Detector.

The development of germanium detectors in the late 1960s completely revolutionized gamma spectroscopy. Fig. 7.1 illustrates the striking contrast in results obtained with the two common types of gamma-ray detectors. Compared to NaI(TI), there is a factor of 30 improvement in the full-width at half-maximum (FWHM) resolution. As a result of this improved resolution, many nuclear energy levels that could not be resolved with NaI(TI) detectors are easily identified by using HPGe detectors.

Concurrently, the development of lithium-drifted silicon detectors [Si(Li)] with drastically-improved energy resolution revolutionized x-ray spectrometry. These Si(Li) devices are studied in Experiment 8.

The purpose of this experiment is to explore some of the properties of HPGe detector systems. This experiment deals only with the

practical aspects of making measurements with these detectors. To understand the properties of these detector systems, the following brief review of gamma-ray interactions and pair-production processes is included.

Gamma-Ray Interactions in HPGe Detectors

Fig. 7.2 shows graphs for the three important gamma-ray interactions in both germanium and silicon. The absorption cross sections for germanium are of interest in this experiment. The corresponding values for silicon will be used in Experiment 8.

When a gamma-ray photon enters a detector, it must produce a recoil electron by one of three processes before it is recorded as an event: (1) the photoelectric effect, (2) the Compton effect, or (3) pair production.

In the **photoelectric process**, the gamma-ray or x-ray photon transfers all of its energy to an electron in the detector. Consequently, the photon vanishes. The recoiling electron loses energy by causing ionization of the detector material, resulting in a trail of electron-hole pairs. The bias voltage applied across the detector sweeps the electrons and holes to opposite electrodes, where the charge is collected to form the preamplifier pulse. For the photoelectric process, the total charge in the output pulse from the detector is proportional to the energy of the gamma-ray or x-ray that produced the interaction. These events will show up as full-energy photopeaks in the spectrum.

In the **Compton process**, the photon is scattered from an electron that is essentially not bound to an atom. Because the scattering angle can vary from 0 to 180 degrees, there is a range of energies that can be transferred from the photon to the recoiling electron. The scattered photon survives

and carries off the remainder of the energy. It is the recoiling electron that loses energy by ionizing the detector material. Consequently, the charge collected from the detector will yield a distribution of pulse amplitudes at the preamplifier output up to some maximum pulse height. This maximum pulse height corresponds to the Compton edge in the energy spectrum, as explained in Experiment 3. There is a statistical probability that each Compton scattering event has an approximately equal chance to produce a pulse with any height up to this maximum. Thus, Compton events will provide a well-distributed low-energy continuum in the spectrum.

In large detectors with high peak-to-Compton ratios, some Compton events also contribute to the full-energy peak, when the scattered photons undergo one or more additional interactions, and finally terminate in complete absorption by the photoelectric interaction.

The pair-production process can also provide a total absorption of the gamma-ray energy. The gamma-ray photon enters the detector and creates an electron-positron pair. All the energy of the initial photon is transferred to the electron-positron pair. Consequently, the initial photon disappears in the process. From the law of conservation of mass and energy, it follows that the initial gamma-ray must have an energy of at least 1.022 MeV, because it takes that much energy to create both the negative and positive electrons. The net mass that is produced is two electron masses, and this satisfies the law of conversion of energy, E, into mass, m, i.e., E = mc². If the initial photon has an energy in excess of 1.022 MeV, that excess energy is transferred into the recoil energies of the positron and electron. Both the positron and the electron lose energy by causing ionization of the atoms in the detector. Once the positron is moving slowly enough, it can be captured by a free electron, and the two can combine. In this annihilation of the positron with an electron, both particles disappear, and their rest mass energies are converted into two photons travelling in opposite directions, with each photon having an energy of 511 keV. Note that the sum of the energies of these two annihilation gamma rays is 1.022 MeV.

High-Resolution Gamma-Ray Spectroscopy

The optional experiment 7.4 explores this process of positron annihilation when the positron is obtained from β^+ decay of a ²²Na radioactive source.

Fig. 7.3 illustrates what happens in the detector in the pair-production process. In Fig. 7.3 the e^- (ordinary electron) will produce a pulse whose magnitude is proportional to the energy of e^- , i.e., E_{e^-} . The positron, e^+ , will produce a pulse proportional to its energy, E_{e^+} . Since these two pulses are produced simultaneously, the output pulse from the detector would be the sum of the two pulses. When the positron annihilates in the detector, the annihilation radiation γ_1 and γ_2 , will be produced. In Fig. 7.3, both γ_1 and γ_2 are shown escaping from the boundaries of the detector without making any further interactions. (Note: $E_{\gamma_1} = E_{\gamma_2} = 0.511$ MeV).






Fig. 7.4. Typical Spectrum for an Incident Gamma-Ray Energy of 2.511 MeV, Showing the Full-Energy, Single-Escape, and Double-Escape Peaks.

Thus, in this example, an energy of exactly 1.022 MeV escapes from the detector, and is subtracted from the total energy that entered the detector. It is possible for only one, either γ_1 or γ_2 , to make a photoelectric interaction in the detector while the other escapes. In such cases, the total energy absorbed is 0.511 MeV less than the original incident gamma-ray energy. It is also possible for both gammas to make photoelectric interactions without escaping, with all the original energy being left in the detector. Therefore, in the spectrum being measured, there will be three peaks for each incident gamma-ray having an energy well in excess of 1.022 MeV. These peaks, labeled Full-Energy Peak, Single-Escape Peak, and Double-Escape Peak, will be separated by 0.511 MeV increments. Fig. 7.4 shows a typical spectrum that would be obtained for an incident

gamma-ray energy of 2.511 MeV. The lower end of the spectrum that shows the Compton distribution has not been included. The Single-Escape Peak occurs at 2.00 MeV (E $_{\gamma}$ – 0.511 MeV), and the Double-Escape Peak occurs at 1.49 MeV (E $_{\gamma}$ – 1.022 MeV). Of course, the full-energy peak represents those events for which there was a combination of pair production and photoelectric effect in which all the energy was absorbed in the detector.




Fig. 7.5. A Typical Spectrum Expected for a 100 keV Photon in a Thin HPGe Detector.

Now refer again to Fig. 7.2, and specifically to the curves for the interaction in germanium. The absorption cross section, plotted in the y direction, is a measure of the relative probability that an interaction will occur in a thin slab of the germanium detector. These probabilities of relative interactions, for the most part, determine the shape of the observed spectrum. For example, a photon with an energy of 100 keV has an absorption cross section of approximately 55 barns/atom for the photoelectric process. The corresponding Compton cross section is about 18 barns/atom. There is no pair

production. These two cross sections are in the approximate ratio of 3:1, at 100 keV, implying that there are 3 times as many photoelectric interactions as Compton interactions. Fig. 7.5 shows the shape of a spectrum that could be expected for measurement of the 100 keV energy events.




Fig. 7.6. A Typical Spectrum Expected for a 1 MeV Photon in a Thin HPGe Detector.


Fig. 7.2 shows that the cross-section for photoelectric absorption drops rapidly with increasing energy. From 300 keV to 3 MeV, the Compton-scattering cross-section dominates. The higher the energy, the more deeply the gamma-ray can penetrate the detector before it interacts with an electron. Consequently, the efficiency can be improved by increasing the dimensions of the Ge detector along the original direction of the photon, and in directions perpendicular to the path of the photon. According to the Beer-Lambert law for absorption (Experiments 2 and 3), a larger detector increases the probability that the photon will interact in the detector. If the initial interaction is a Compton scattering, the larger detector dimensions improve the chances that the scattered photon will be stopped by a photoelectric absorption before it leaves the detector volume, placing the event in the full-energy peak. Consequently, a larger detector improves the ratio of counts in the full-energy peak to the counts in the Compton continuum. This improves detection limits for weak peaks that would be obscured by statistical fluctuations in the Compton continuum from higher-energy gamma rays.

The shape of the spectrum changes drastically from 100 keV to 1 MeV. Fig. 7.6 shows the gamma spectrum that could be expected for the 1 MeV gammas incident on a thin HPGe detector. From Fig. 7.2, the ratio of Compton cross section to photoelectric cross section is approximately 90; so, in Fig. 7.6, the sum of the counts in the Compton distribution is Σ_c = 90,000 and the sum of the counts in the photopeak is Σ_{pp} = 1000.

The relative efficiencies for HPGe and Si(Li) detectors can also be approximated from Fig. 7.2. For example, at E_V = 400 keV the photoelectric cross section for germanium is 6 barns/atom, and that for silicon is approximately 0.1 barn/atom. This is a ratio of 60:1, and indicates that there will be 60 times as many counts under the photopeak for a germanium detector as for a silicon detector at 400 keV, assuming that the detectors are the same size. This ratio of detector efficiencies reflects the fact that the photoelectric cross section varies as Z5, where Z is the atomic number of the absorbing material. The atomic number of Ge is 32 and for Si it is 14. The ratio of these two numbers raised to the 5th power is 62.2, which agrees remarkably well with the above cross-section ratios. Higher atomic numbers offer greater photopeak efficiencies.

Detector Structure


Basically, a HPGe detector is a very large semiconductor diode, with a reverse bias voltage applied to its two electrodes to deplete virtually all free charge carriers from the bulk of the detector. Small detectors can be obtained in the planar geometry that is similar to the structure of the silicon charged-particle detectors studied in experiments 4, 5 and 6. Figure 7.7 illustrates the planar geometry. The detector is a cylinder of HPGe with electrodes applied to its two circular ends.

Significantly larger detectors benefit from using the coaxial geometry depicted in Fig. 7.8. The P-type HPGe (GEM) is the type of detector used in this experiment. The detector is composed of a large cylinder of high-purity germanium. A hole is drilled from one end, along the centerline of the cylinder. One electrode is applied to the outer surface of the cylinder and to the closed end. The other electrode is applied to the inside surface of the central hole. The surface of the end from which the hole is drilled (open end) is passivated to reduce surface leakage currents between the two electrodes. The coaxial detector shape is mounted in the end cap of the cryostat, with the cylindrical axis of the detector diode aligned coaxially with the centerline of the end cap. The closed end of the detector is located a few millimeters behind the circular surface of the end cap.

The detector and the first amplifying stage of the preamplifier are operated near the boiling temperature of liquid nitrogen (77°K) to reduce noise. Consequently, the detector and the first stage of the preamplifier are mounted in a vacuum cryostat. The cryostat establishes operation at the desired low temperature via a copper cooling rod dipped in the liquid nitrogen contained in the associated dewar. Operation at the cryogenic temperature dramatically reduces the leakage current in the HPGe detector and also diminishes thermally generated noise in the FET input stage of the preamplifier. The preamplifier feedback capacitor and feedback resistor are also cooled to reduce their noise contribution. As will be seen next, decreasing these sources of noise improves the energy resolution.

Experiment 7 High-Resolution Gamma-Ray Spectroscopy

Energy Resolution

The energy resolution of a HPGe detector is described by equation (2).

$$\Delta E_{total} = \sqrt{(\Delta E_{noise})^2 + (\Delta E_{ion})^2 + (\Delta E_{incomplete})^2}$$
 (2a)

where

$$\Delta E_{ion} = 2.35 \sqrt{\epsilon FE} \tag{2b}$$

 ΔE_{total} is the full width at half maximum amplitude (FWHM) of the gamma-ray peak at energy E in the spectrum. ΔE_{noise} is the contribution from the noise caused by the detector leakage current and the preamplifier. It is most readily measured as the FWHM of a pulser peak artificially introduced into the spectrum by injecting a pulser signal into the input of the preamplifier. The noise contribution is independent of the gamma-ray energy. But, it does depend on the shaping time constant of the spectroscopy amplifier. If the shaping time constant is too small or too large, the noise contribution will be higher than the optimum. Check the detector data sheet for the optimum shaping time constant to minimize the noise. The optimum will likely lie in the range of 3 to 6 microseconds.

 ΔE_{ion} describes the variation in the number of electron-hole pairs generated as a result of ionization statistics. It depends on the average energy required to create an electron-hole pair (i.e., $\epsilon = 2.95$ eV), the energy of the gamma-ray, E, and the Fano factor, F. Note that the same units of energy must be used throughout equation (2). The Fano factor accounts for the fact that the ionization process lies somewhere between completely independent random ionization events at one extreme (F = 1), and an absolutely deterministic conversion of energy into electron-hole pairs at the other extreme (F = 0). For HPGe a Fano factor, F \approx 0.1, indicates the process is closer to the latter than the former condition.

 $\Delta E_{incomplete}$ accounts for the variation in the ability to collect all of the electron-hole pairs that are created by the ionization process. Primarily, this applies to electron-hole pairs that recombine before they can be collected, or charge carriers that fall into traps while drifting to their respective electrode. Additionally, there is potential for a ballistic deficit effect when the shaping time constant is too small. For large coaxial HPGe detectors the charge collection time can vary from 50 to 700 ns, depending on the position at which the charge was created. If the amplifier shaping time constant is not large compared to these collection times, the pulse height will show additional fluctuations caused by random variations in the charge collection times. If the incomplete charge collection term is ignored in equation (2), spectral resolution measurements may lead to an inflated value for the implied Fano factor.

Maximum Counting Rate Deduced from the Percent Dead Time

Because gamma rays arrive at the detector with random spacing in time, the width of the pulse from the amplifier limits the counting rate that can be processed without distortion. Probably the most efficient way to ensure that the maximum counting rate is not exceeded is to adjust the source-to-detector distance so that the percent dead time observed on the Multichannel Analyzer is less than 63%. The dominant dead time in the gamma-ray spectrometer specified for this experiment is a paralyzable (a.k.a., extending) dead time (ref. 11, 14 and 15). For a paralyzable dead time, the maximum analyzed throughput is accomplished when the dead time is 63%. Operation at counting rates that yield slightly less than 63% dead time will provide optimum performance.


EXPERIMENT 7.1. Energy Resolution with a HPGe Detector

CAUTION

The instructor will provide the HPGe detector and instructions for its use. Before attempting to use the detector, carefully read the instruction manual. This is a very expensive detector system and must be handled very carefully.

Procedure

- Turn off power to the 4001A/4002D NIM Bin and the 659 5-kV Detector Bias Supply. Turn the 0–5 kV dial on the 659 to its minimum value (full counter-clockwise).
- Install the 659, 480 and 672 in the 4001A/4002D NIM Bin and interconnect the modules as shown in Fig. 7.9. The preamplifier is mounted as an integral part of the HPGe detector and the preamplifier input is internally connected to the detector in the cryostat.



- 3. Using the cable bundle supplied with the detector, connect the preamplifier power to the PREAMP power connector on the rear panel of the 672 Spectroscopy Amplifier. Connect the preamplifier signal output to the NORMal INPUT of the 672 Amplifier. Connect the Test Input of the preamplifier to the ATTENuated OUTPUT of the 480 Pulser. Connect the Bias Voltage input on the preamplifier to the 0–5 kV OUTPUT on the rear panel of the 659 bias supply. Connect
- 4. Connect the UNIPOLAR OUTPUT of the 672 Amplifier to a Tee on the Channel-1 Input on the oscilloscope. Connect the other arm of that Tee to the analog signal INPUT on the EASY-MCA-8K.

the BIAS SHUTDOWN on the rear of the 659 to the Auto HV Shutdown connector on the preamplifier.

- 5. Connect the BUSY output of the 672 to the BUSY input on the EASY-MCA-8K. Connect the PUR (Pile-Up Rejector) output of the 672 to the PUR input of the EASY-MCA-8K.
- 6. Ensure that the EASY-MCA-8K is connected to the supporting computer via the USB cable, and that MAESTRO is installed on the computer.
- 7. Set the module controls as follows:
 - 672 Amplifier: GAUSSIAN UNI SHAPING, AUTO PZ, 6- μ s SHAPING TIME, NORMal (+) INPUT, AUTO BLR RATE.
 - 480 Pulser: POSitive polarity, OFF.
 - 659 0–5 kV Detector Bias Supply: Leave at zero until all other connections have been made. The GEM HPGe detector specified for this experiment requires a positive bias voltage. But, consult the instructions for the detector to determine both the bias polarity and the bias voltage required for the detector. Check the polarity indicated on the 659 front-panel POS/NEG LEDs when the bin power is turned on. Make sure the indicated polarity is correct for the detector. Apply the correct bias voltage with the correct polarity when ready to operate the detector.
- 8. Turn on the Bin power. Turn on the Detector Bias Supply, and adjust the voltage to the value required for the detector.
- 9. Via MAESTRO, select a Conversion Gain of 8192 channels full scale for the MCA digital resolution. Set the Lower Level Discriminator to circa 80 channels and the Upper Level Discriminator to 8192 channels. Check that the Gating function is turned off.

- 10. Place the ⁶⁰Co source approximately 1 cm from the face of the detector. Adjust the gain of the 672 Amplifier so that the 1.333 MeV gamma has an amplitude of +8 V at the amplifier unipolar output. The two lines for 1.173 and 1.333 MeV should be quite easily seen on the oscilloscope. Lock the FINE GAIN dial on the amplifier to discourage accidental changes in the established energy calibration. The recommended settings in step 7 are correct for the specified GEM detector. But, a different detector model may have the opposite polarity for the preamplifier output signal. If that is the case, change the amplifier input polarity switch so that the UNIPOLAR OUTPUT has a positive polarity.
- 11. Check that the percent dead time when acquiring a spectrum on the MCA is <63%. Adjust the source-to-detector distance to meet this condition, if necessary.
- 12. To make the PZ adjustment, switch the BLR RATE switch to the PZ position for the duration of this adjustment. The 672 Amplifier controls have been set up to utilize the Automatic Pole-Zero Adjustment feature. To observe its operation, turn the oscilloscope to the most sensitive vertical scale. Select a horizontal scale of 50 microseconds per major division. Push the LIMIT pushbutton on the 672 front panel near the UNIPOLAR OUTPUT. On the oscilloscope, observe that this pushbutton limits the pulse amplitude and prevents distortions that would otherwise be caused by overloading the oscilloscope input.
- 13. While continuing to depress the limit switch, briefly press the AUTO PZ pushbutton on the front panel of the 672. The red BUSY LED should light up, and you should be able to track the automatic adjustment of the PZ on the oscilloscope. Confirm that the PZ is correctly adjusted. You can opt for a manual adjustment by moving the PZ switch from AUTO to MANual, and adjusting the screwdriver control as learned in previous experiments. But, the AUTO PZ adjustment will probably be more accurate. After the PZ adjustment has been accomplished, return the BLR RATE switch to the AUTO position. For an explanation of the BLR (baseline restorer) function, see ref. 14, and the specification sheet or instruction manual for the 672 Amplifier.




Fig. 7.10. Locating the Peaks and Compton Edges in the [®]Co Spectrum with the HPGe Gamma-ray Spectrometer.

- 14. Make an acquisition on the MCA for a long enough period of time to create a well-defined spectrum as illustrated in Fig. 7.10.
- 15. Save a copy of the ⁶⁰Co spectrum on the internal hard drive for potential later use.
- 16. From the positions of the two photopeaks, make a calibration curve of energy (y direction) vs. channel number (x direction) and determine the keV per channel.
- 17. Remove the ⁶⁰Co source and turn on the 480 Pulser. Using the ATTENUATOR switches and PULSE HEIGHT dial, place the pulser peak approximately mid way between the two ⁶⁰Co peaks in the spectrum. Acquire enough counts to achieve a well-defined pulser peak in the spectrum. Save this spectrum on the internal hard disk for potential later reference.

EXERCISES

- a. What is the FWHM resolution in keV for the two photopeaks? How does this compare in value with the detector's resolution specifications? What is the FWHM resolution of the Pulser peak?
- b. Presume that $\Delta E_{incomplete} = 0$ in equation (2). Using your measured resolutions on the two peaks from 60 Co and the Pulser peak, calculate the effective value of the Fano factor, F, in equation (2b). How does your value compare to the referenced value of F = 0.1? Why does your result differ from the referenced value?
- c. Using your measured value for the Fano factor and the Pulser resolution, calculate the values for ΔE_{total} from equation (2), to fill in the blank column in Table 7.2.
- d. Make a plot of the data in Table 7.2 on linear graph paper.

e. From the ⁶⁰Co spectrum, determine the energies of the Compton edges associated with the two gamma-ray energies. How do these compare with the values that were calculated from the formula used in Experiment 3?

EXPERIMENT 7.2. Photopeak Efficiency and Peak-to-Compton Ratio

Compared to Nal(Tl) detectors, the energy resolution with HPGe detectors is better by a factor of 30 or more. This dramatic increase in resolution is sometimes coupled with a compromise of the photopeak efficiency, because the larger-volume HPGe detectors that deliver higher photopeak efficiency are much more expensive to manufacture. Thus a smaller, lower-efficiency, HPGe detector is employed with this experiment to reduce the cost. Normally, the efficiency listed for a HPGe detector is


expressed as a ratio to the efficiency expected for a 3-inch x 3-inch Nal(Tl) detector. The standard method for comparing the efficiencies of HPGe detectors with Nal(Tl) detectors is to compare their counting rates at the 1.333 MeV line of ⁶⁰Co, using a standard distance of 25 cm from the source to the detector face, and placing the source on the detector axial centerline.

The resolution of HPGe detectors is so many times better than that of Nal(TI) that the ability to see a photopeak above the Compton distribution is remarkably enhanced. Consider a simple example in which the efficiencies of the HPGe and Nal(TI) detectors are assumed to be the same. Presume that in a particular experiment, we observe 10,000 counts under the photopeak for each detector. If the resolution of the HPGe detector is 10 times better than the Nal(TI)detector resolution, the HPGe detector will have a peak height that is 10 times the peak height exhibited by the Nal(TI) detector. This relationship results because the area under the photopeak (10,000 in this example) is approximately proportional to the width times the height of the peak. Since the width of the HPGe peak is 1/10 the width of the Nal(TI) peak, its height must be 10 times as great.

This example can be easily extrapolated to real situations where the advantages of superior resolution are very important. For example, Fig. 7.11 shows the striking differences for comparative spectra obtained on a mixed sample of ⁷⁶As, ¹²²Sb, and ¹²⁴Sb with the two types of detectors. Each of the closely spaced energy lines is shown separately in the HPGe spectrum, while they are all included in a single broad photopeak in the NaI(TI) spectrum. In this experiment, we will measure some of these photopeak efficiencies and also determine the peak-to-Compton ratio for a HPGe detector.

The peak-to-Compton ratio is a pragmatic parameter that provides a relative comparison between the abilities of two different detectors to detect low-intensity peaks on the

continuum caused by Compton scattering. It includes the effect of energy resolution and the full-energy peak efficiency of the detector. The peak-to-Compton ratio is the height of the 1.333 MeV full-energy peak from a ⁶⁰Co source, divided by the height of the Compton continuum from that same spectrum between 1.040 and 1.096 MeV. HPGe detectors with a larger volume have a higher probability that the detected gamma-ray will end up in the full-energy peak, instead of the Compton continuum. That improves the peak-to-Compton ratio. Unfortunately, higher-volume detectors tend to have slightly worse energy resolution, and that detracts from the peak-to-Compton ratio. Fortunately, the improved efficiency tends to dominate the degraded energy resolution, causing higher-volume detectors to have better detection limits for low-activity peaks.

Procedure

- 1. Continue with the same equipment setup that was used for Experiment 7.1.
- 2. Place the ⁶⁰Co source 25 cm from the end cap of the HPGe detector, and on the axial centerline of the detector.




Fig. 7.12. Measuring the Peak-to-Compton Ratio on a ⁶⁰Co Spectrum.

- 3. Accumulate the spectrum in the MCA for a time period long enough to determine heights h1 and h2 to a fair degree of accuracy. In Fig. 7.12, h1 is the height of the 1.3332 MeV photopeak from the ⁶⁰Co radioisotope, and h2 is the height for the Compton distribution, located just below the Compton edge (between 1.040 and 1.096 MeV). Read the data from the MCA.
- 4. Save the spectrum to the internal hard disk for potential use later.

EXERCISE

a. Calculate the peak-to-Compton ratio, which is h1 divided by h2 in Fig. 7.12. Compare your value with the specification for this detector. Check with your laboratory instructor for the record of the ratio.

- 5. Clear the spectrum from the MCA.
- 6. Place a 10-μCi ⁶⁰Co source at a distance of exactly 25 cm from the face of the detector.
- 7. Accumulate a spectrum for this source with approximately 3000 counts under the 1.333 MeV photopeak.
- 8. Set a Region of Interest across the entire 1.333 MeV photopeak and read the total number of counts in the peak, Σ_{pp} . Also write down the elapsed live time for the spectrum, t_L .
- 9. Save the spectrum on the internal hard disk for potential later use.

EXERCISES

b. Divide the number of counts in the 1.333 MeV photopeak by the elapsed live time. Call this counting rate R₁.

$$R_1 = \frac{\sum_{pp}}{t_1}$$
 (3)

c. The rate, R_1 from Eq. (3) is to be compared with the rate, R_2 , that is expected for the same source when it is located 25 cm from the face of a 3-in. x 3-in. Nal(Tl)detector. The efficiency of this size Nal(Tl) detector for a source-to-detector distance of 25 cm is given as $\varepsilon_2 = 1.2 \times 10^{-3}$, (from "Gamma Ray Spectrum Catalog" by R. L. Heath, Idaho Falls Report IDO-16880). Using this efficiency number, the counting rate (R_2), that you would observe under the photopeak for a 3-in. x 3-in. Nal(Tl) detector at 25 cm source distance is given by

$$R_2 = \varepsilon_2 A \tag{4}$$

where A is the gamma-ray activity of the source in counts per second.

Since 60Co has one 1.3332 MeV gamma ray for each decay, A is given by

$$A = 3.7 \times 10^4 a$$
 (5)

Where "a" is the source strength in microCuries (μ Ci).

R₂ can be calculated from equations (4) and (5). Subsequently, the relative photopeak efficiency for the HPGe detector is obtained from:

Relative Photopeak Efficiency =
$$\frac{R_1}{R_2}$$
 x 100% (6)

d. Calculate the relative photopeak efficiency for your measurement, and compare it with the value that is specified for the detector. Check with your laboratory instructor for the record of the detector's efficiency.

EXPERIMENT 7.3. Escape Peaks and Efficiency for HPGe Detectors

As discussed earlier, when an incident gamma-ray with sufficient energy enters the crystal it can create an electron-positron pair. When the positron annihilates, two gammas with equal energy at 0.511 MeV are produced which leave with an angular separation of 180°. In Fig. 7.3, these two gammas are shown as γ_1 and γ_2 . For small detectors, it is very probable that both γ_1 and γ_2 will escape from the detector before they make any further interactions in the crystal. The energy thus absorbed would be $E_{\gamma} - 1.022$ MeV, and is shown as the Double-Escape Peak in Fig. 7.4. As the detector size increases, the probability is greater that either γ_1 or γ_2 will make a photoelectric interaction within the crystal. If one of these gammas does undergo a photoelectric interaction, the energy of the event that is recorded in the detector is the Single-Escape Peak in Fig. 7.4. For even larger detectors, the probability of both γ_1 and γ_2 being absorbed by photoelectric interactions is even greater, making it more likely that the total energy of the original gamma-ray is absorbed in the crystal.





Fig. 7.13. Measured Full-Energy and Escape-Peak Efficiencies for HPGe Detectors of Different Sizes.

Fig. 7.13 shows some measurements that have been made for coaxial and planar HPGe detectors. From this figure, the ratios of Full-Energy, Double-Escape Peak, and Single-Escape Peak efficiencies can be determined by inspection for the size of detector that is identified in the figure.

To see how the measurements were made for Fig. 7.13, consider the E γ of 2.511 MeV shown in Fig. 7.4. Assume that the Compton distribution has been subtracted for each peak in Fig. 7.4, and that the following sums have been measured:

 Σ at Full Energy (2.511 MeV) = 6000,

 Σ at Single-Escape (2.00 MeV) = 1000

 Σ at Double-Escape (1.489 MeV) = 3000.

From these numbers the simple ratios can be obtained.

Procedure

For this experiment, the same equipment setup that was used for Experiment 7.1 will be used. But, the energy calibration will be changed to accommodate the 2.614 MeV gamma-ray from the ^{228}Th source. As detailed in Experiment 4, ^{228}Th is part of a natural decay series that involves sequences of alpha and β^- decays, ultimately ending up with a stable ^{208}Pb isotope. The 2.614 MeV gamma-ray is generated from an excited state in ^{208}Pb near the end of that series, as ^{208}Tl decays by alpha

emission into ²⁰⁸Pb. Several gamma-ray sources, ⁵⁷Co, ¹³⁷Cs, and ⁶⁰Co will be used along with the ²²⁸Th source to establish the new energy calibration.

- 1. Place the ⁶⁰Co source in front of the detector. Adjust the amplifier gain so that the 1.333 MeV gamma-rays produce a 4.1 V pulse height on the oscilloscope. Lock the Amplifier FINE GAIN dial so that the energy calibration will not be accidentally altered.
- 2. Check that the percent dead time on the MCA is <63%. Adjust the source-to-detector distance to meet that condition, if necessary.
- 3. Acquire a spectrum with the 60Co source until the peaks are statistically well defined.
- 4. Measure the channel centroids of the 1.333 and 1.173 MeV peaks, and record them for energy calibration. The 1.333 MeV peak should be in the neighborhood of channel 3,342. If it deviates by more than 250 channels from this location, readjust the Amplifier gain to bring it into compliance. Lock the Amplifier FINE GAIN dial to maintain this energy calibration. Save the spectrum for possible later reference.
- 5. Replace the ⁶⁰Co source with the ¹³⁷Cs source and acquire a spectrum. If necessary, adjust the source-to-detector distance to achieve <63% dead time. Measure the channel centroid of the 662 keV peak and record the value. Save the spectrum for possible future reference.
- 6. Replace the ¹³⁷Cs source with the ⁵⁷Co source. If necessary, adjust the source-to-detector distance to achieve <63% dead time. Acquire a spectrum. Measure the channel centroids of the 122 keV and 136.5 keV peaks, and record those values. Save the spectrum for possible future reference.
- 7. ALTERNATIVELY, the three sources can be combined into one spectrum for the energy calibration measurement. In this scheme, place the ⁵⁷Co source directly on the center of the detector end-cap. Stack the ¹³⁷Cs source on top of the ⁵⁷Co source, and add the ⁶⁰Co source on top of the ¹³⁷Cs source. If necessary, adjust the source-to-detector

distance to achieve <63% dead time. Acquire a spectrum for a sufficient length of time so that all the peaks of interest are statistically well defined above the background caused by the Compton continua. Save the spectrum for possible later reference.

- 8. Use the energy calibration feature of MAESTRO to calibrate the horizontal axis in keV or MeV. If employing the composite spectrum, make sure that you use the net area above the local background to compute the centroids.
- 9. Remove the energy calibration sources and place the ²²⁸Th in front of the detector at a 3 cm distance from the detector along the axial centerline of the detector. If necessary, increase the source-to-detector distance to achieve <63% dead time. Accumulate a spectrum long enough to achieve statistically well-defined peaks for all of the major peaks of interest. Save the spectrum for future use.
- 10. If you plan to complete your report after you leave the laboratory, transfer all the saved spectra to a transportable storage device, such as a portable hard disk, memory stick, or CD for later analysis and plotting. The most efficient way to achieve this goal is to use the MAESTRO option to save (export) the spectrum as an ASCII file. The ASCII file can be imported into an Excel spreadsheet. Choose the Tab and Space Delineated option in Excel when importing the file. This generates the file header and the channel-by-channel counts as a table in Excel. That data can be plotted with the Excel graphing options, and labeling can be inserted on each peak in the spectrum. The resulting Excel graph can be imported into your lab report and printed. Another option for including spectra in your report is to capture an image of the spectra on the laboratory computer display using the FullShot image capture software provided with MAESTRO.

EXERCISES

- a. Plot the ²²⁸Th spectrum with a logarithmic vertical (counts) scale and a linear horizontal (energy) scale. On the plot, identify all the major peaks and the corresponding escape peaks. Compare the energies you measured for these peaks with those that are listed for the source in references 10 or 12.
- b. Do the escape peaks associated with the 2.614 MeV gamma-ray occur at the correct energies? If not, does adding the 2.614 MeV gamma-ray and its escape peaks to the above energy calibration improve the agreement?
- c. Calculate the escape peak ratios. Define Σ_f as the sum of counts under the full-energy peak, Σ_1 as the sum under the single-escape peak, and Σ_2 as the sum under the double-escape peak. Be sure to subtract the background caused by the Compton distribution from these sums; then determine the ratios Σ_f/Σ_1 , Σ_f/Σ_2 , and Σ_2/Σ_1 . How do these ratios compare with those the laboratory instructor has for the ²²⁸Th source and the detector you are using?
- d. How will a different source-to-detector distance affect the escape peak ratios?

EXPERIMENT 7.4. Doppler Broadening with Annihilation Radiation (Optional)

As previously discussed, when a positron combines with an electron, the pair annihilate each other and two 511 keV gamma rays are emitted in opposite directions. The rest masses of the positron and electron are converted to energy in the form of the two gamma rays. That is the simple picture. When examined in more detail, one finds that the process is sensitive to the binding energy of the electron in an atom, and the momenta carried by the positron and the electron at the time of annihilation (ref. 11, 16 and 17). The binding energy of the electron can lower the gamma-ray energy as much as 10 eV below the rest mass equivalent energy of an electron (511.003 keV), and the amount of this shift will depend on the material in which the positron finds the electron.

More importantly, the energy of the annihilation gamma ray can vary by as much as 1 keV because of the possible range of residual momentum at the time of annihilation. Because this energy variability is of the order of the energy resolution one expects at 511 keV with a HPGe detector, there will be a noticeable broadening of the 511 keV peak width. The effect is commonly referred to as Doppler Broadening of the peak shape. The amount of Doppler Broadening depends on the material in which the positron is annihilating, and on conditions that affect the population of available electrons in the material. Consequently, Doppler Broadening is one of the techniques used with positron sources to study chemical states, stress and microscopic voids in materials (ref. 16 and 17).

Experiment 7 High-Resolution Gamma-Ray Spectroscopy

The energy shift and Doppler Broadening make positron annihilation a useful tool for studying materials. But, when performing an energy calibration and resolution check on a HPGe detector, the 511 keV annihilation radiation from a radioactive 22 Na source can be misleading. 22 Na has a half life of 2.60 years. It decays by positron emission (90%) or electron capture (10%) to the 1.2746 MeV excited state of 22 Ne. The lifetime of the excited state is 3 picoseconds. Consequently, emission of the 1.2746 MeV gamma ray is a prompt signal that either electron capture or β^+ decay has occurred. The end-point energy for the β^+ decay to the excited state is 0.545 MeV. The positron has to lose most of the 0.545 MeV in the surrounding material before it has a high probability of being captured by an electron to cause the annihilation. That implies a maximum penetration depth of the order of a millimeter or less in metals. Near the end of the energy-loss process the positron annihilates with an electron. Obviously, the rate of energy loss and the range of the positron are going to depend on the absorbing material. The residual momentum at the time of annihilation also depends on local variations in the population of available electrons. Consequently, the Doppler Broadening will depend on the nature of the absorbing material.

In this experiment a thin ²²Na source with minimal window thickness will be used. This enables the experimenter to sandwich the positron source between different absorbing materials to measure the Doppler Broadening on the 511 keV annihilation gamma rays. The thickness of aluminum required to stop the 0.545 MeV positrons is approximately 1 mm or 0.039 inches. For Nickel, the range of 0.545 MeV positrons is approximately 0.32 mm, or 0.013 inches. For both metals, the foil thicknesses actually employed will transmit 90% to 99% of the 511 keV gamma-rays that are generated.

Procedure

- 1. This experiment will use the same spectrometer set-up as employed in Experiment 7.3, except the gain will be changed to place the 662 keV gamma-ray near the upper end of the energy spectrum on the MCA.
- 2. Remove all other sources from the vicinity of the HPGe detector, and place the ¹³⁷Cs source at a distance that yields a percent dead time <63%.
- 3. Observe the pulses on the oscilloscope, and adjust the amplifier gain to make the pulse height of the 662 keV gamma ray approximately 9 V.
- 4. Acquire a spectrum on the MCA and determine the channel number for the position of the 662 keV peak. If it is not within ±200 channels of channel number 7400, adjust the amplifier gain to bring the peak position within those limits. Lock the amplifier FINE GAIN dial to discourage accidental changes in the energy calibration.
- 5. Ensure that the 662-keV peak has sufficient counts to enable an accurate measurement of its centroid position and the FWHM in channels. When determining the channel numbers that correspond to half the height of the peak, it will be helpful to interpolate to a tenth of a channel. Alternatively, a region of interest can be set over the peak, and MAESTRO can be used to measure the centroid and the FWHM. Record the peak position and the FWHM. Save the spectrum for possible later reference.
- 6. Remove the ¹³⁷Cs source and replace it with the ⁵⁷Co source. If necessary, adjust the source-to-detector distance so that the dead time is <63%.
- 7. Acquire a spectrum with sufficient counts to accurately measure the centroids of the 122 and 136.5 keV peaks. Save the spectrum for possible later reference.
- 8. Use the Energy Calibration feature of MAESTRO to calibrate the cursor to read in MeV or keV based on the peak positions from ⁵⁷Co and ¹³⁷Cs.
- 9. Remove the sources and turn on the pulse generator. Acquire a spectrum with the pulser peak at about channel 7000. Ensure that the peak contains enough counts to measure the FWHM of the peak accurately. Record that Pulser FWHM, and save the spectrum for possible later reference.

	EXERCISE
a.	Calculate the FWHM energy resolution of the 662 keV peak, ΔE_{total} , and the Pulser peak, ΔE_{noise} , in eV. From these two numbers and Equation (2) calculate the effective Fano factor by presuming $\Delta E_{incomplete} = 0$.
10.	Turn off the Pulser and assemble the source and foil sandwich. From the FOIL-AL-30 kit place two aluminum foils on one side of the thin ²² Na source for a total foil thickness of 1.5 mm on that side of the sandwich. Also apply two foils to the other side of the ²² Na source to complete the symmetrical sandwich.
11.	Place the assembly in front of the detector on the axial centerline of the detector, with the foils parallel to the circular surface of the detector end cap. If necessary, adjust the sandwich-to-detector distance to ensure the dead time is <63%.
12.	Acquire a spectrum for a sufficient length of time to form a statistically well-defined peak at 511 keV. Save this spectrum for possible future reference.
13.	Set a region of interest (ROI) across the 511 keV peak. This peak sits on a background generated by the Compton continuum from the 1.2746 MeV gamma ray. Therefore, it is important to ensure that the limits of the ROI extend into that background on either side of the peak. Use the ROI features of MAESTRO to measure the peak position and FWHM in keV. Record those numbers.
	EXERCISES
b.	From equation (2) and the effective Fano factor computed in Exercise a., calculate the predicted energy resolution at 511 keV, i.e., $\Delta E(511)_{predicted} = \Delta E_{total}$.
C.	If the Doppler Broadening has a Gaussian distribution, the FWHM of that broadening can be computed from
	$\Delta E_{DB} = \sqrt{[\Delta E(511)_{actual}]^2 - [\Delta E(511)_{predicted}]^2}$
	Where $\Delta E(511)_{actual}$ is the FWHM measured in step 13. Calculate ΔE_{DB} for aluminum.
d.	Plot the profiles of the 662 keV peak and the 511 keV peak in the vicinity of each peak to compare the widths and symmetry. What differences do you see in peak shapes?
e.	How does the measured centroid for the 511 keV peak compare to the energy that would be expected if there were no shift from the binding energy of the electrons in aluminum, and no Doppler Broadening?
14.	Repeat steps 10 through 13 and Exercises b. through e., with the sandwich assembled using two nickel foils from the Foil-Ni-10 kit on each side of the source, instead of the aluminum foils. The total nickel foil thickness on each side of the sandwich should be 0.51 mm.
	EXERCISE
f.	In addition to repeating Exercises b. through e. for nickel, compare the Doppler Broadening for the nickel to the Doppler Broadening for the aluminum. Nickel is reputed to have the largest Doppler Broadening compared to all the other pure metals in the annealed state. Are your measurements consistent with that expectation?

Although not attempted in this experiment, it is well known that stressing a metal by repeated flexing, or by hammering the surface, causes additional Doppler Broadening. Subsequent annealing of the metal returns the

Doppler Broadening to its lower value. What is a possible explanation for this phenomenon?
